## Experience:

A minimum of ten years of operational and administrative experience in safety management of all or some of the following areas:

- (i) Storage and handling of Chemical and Gas cylinders.
- (ii) Storage and handling of Biological, Medical and Radiological items and related activities.
- (iii) Electrical Installation
- (iv) Fire

(v) Cryogens and lasers.

#### Desirable:

Degree/ P.G. Diploma/Master's degree in occupational safety management & Health Engineering and Management/Industrial Safety/Safety Engineering from a recognized university/Institution.

Based on the criteria mentioned above, 22 candidates have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application.
