The Institute vide Advt. No. Mission Mode (DR) (2) / 2023 dated February 14, 2023 invited online applications for filling-up 01 post (i.e. 01-UR) of Joint Sports Officer in Level-10 of Pay Matrix as per 7th CPC for Sports Administration Cadre, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria was mentioned in the advertisement:

Essential:

- (i) A Master's Degree in Physical Education or Master's Degree in Sports Science or equivalent with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) with a consistently good academic record.
- (ii) Record of having represented the University/College at the Inter-University/Inter-Collegiate competitions or state and /or national championships.
- (iii) Passed the physical fitness test conducted in accordance with these regulations.
- (iv) Minimum 03 years of relevant experience of working in Institute / University of State / Centre Govt. organization.

Desirable:

Qualifying in the National-Level Test conducted for the purpose by the UGC or any other agency approved by the UGC.

In addition to essential qualification, the Committee decided to adopt the following criteria for shortlisting purposes:

- (i) The Committee increased the minimum relevant experience from 03 years to 05 years.
- (ii) Relevant experience (i.e., 05 years) in government / government -aided bodies was also considered.

As per Para 6 of the General Instructions of the advertisement, "In case, applications received are in excess of the number of posts advertised for the vacant posts, the Scrutiny/ Shortlisting Committee may adopt additional/higher criteria for shortlisting, based on academic performance and/ or years of experience of the applicants or it may so decide, and the shortlisted applicants will be called for certain evaluation process and subsequent stage(s) as applicable on qualifying the same as per decision of the Institute".

Based on the adopted criteria mentioned above, **34** applicants have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
